By signing this agreement, I agree to the following terms and conditions:

I apply to rent a bicycle locker for a three month period at the following rates (identify start date and location):

Important: * The rental agreement will commence the 1st of the month following receipt of payment.
* Locker rental payments are nonrefundable
* Lockers must be renewed every three months

Subject to TransLink's right to terminate this agreement, I acknowledge that I may renew this rental for successive 3-month periods provided that I have prepaid the locker rental fees by the commencement of the renewal period.

I agree to make the following payments for use of the locker¹:

- Locker rental fees (including GST), as identified above, payable in advance: and
- Security deposit of \$50.00, refundable without interest upon termination of this agreement, provided I have returned the locker key and I have left the locker in good condition.

I agree to use the locker only for the purpose of storing a bicycle and cycling-related clothing and equipment that can be reasonably contained in the locker. I agree any other use may result in automatic termination of this agreement or other legal action.

I agree that I am personally responsible for any damage to the locker caused by my use. I am further responsible for keeping the interior of the locker clean and free of any garbage or other debris and for ensuring the locker is secure at all times.

I will report problems with the locker, including vandalism and lost keys to **Translink, c/o C-Media at 604-924-1076**, at bike_locker_requests@cmediaoutdoor.com, or at the address set out below. I acknowledge that if I require a replacement locker key, I will forfeit my security deposit and will be charged for a new lock and key.

I am aware that TransLink may from time to time require access to the locker for maintenance and repair and I agree to provide such access upon 24 hours notice. In an emergency, TransLink may gain access to the locker without notice. I agree that TransLink may periodically inspect the locker to ensure that it is being used by me in accordance with the terms of the agreement.

TransLink is not liable for any injuries, losses or damages arising from my use of the locker. I am personally responsible for any such injuries, losses or damages and am responsible for insuring the contents of the locker against loss or damage.

I agree that TransLink has the right to terminate this agreement: (a) at any time upon 30 days written notice to me, or (b) immediately if I fail to comply with any of the provisions of this agreement.

I further agree that in the event that I fail to remove any items from the locker at the end of the rental period or within one week's notice from TransLink of termination of this agreement, TransLink will be entitled to retain my security deposit, treat such items as abandoned and dispose of them in any manner TransLink considers appropriate with no further notice or obligation to me.

I understand that TransLink must collect, retain and use my personal information as disclosed above to operate the Bike Locker Rental Program, including to: (1) enable me to participate on a continuing basis; and (2) permit collection and enforcement of payment: and I consent to such collection, retention and use. I am aware that such collection, use and retention is authorized by section 26(c) of the Freedom of Information and Protection of Privacy Act for the purpose of ensuring the proper administration of the Program.
